#### STANDARD 90 DAYS PARTS WARRANTY

- 1. Unit is warranteed under normal use and proper maintenance, for a period of 90 days from date of factory shipment to the original purchaser. This applies to all items except consumable parts (i.e. water filters, screen filters, oil filters, flexure's, shear mounts, and other suspensions parts, etc.).
- 2. This warranty covers parts and labor only and is limited to repairing or replacing parts which have been returned to LR Environmental and in our opinion are defective. It is contingent upon Buyer providing written notice of defective parts within 10 days after discovery and within the warranty period. Any repaired or replaced parts will be warranteed for the balance of the original equipment warranty period.
- 3. Service labor required to correct defects in material and/or workmanship will be supplied by LR Environmental without charge. Any transportation costs and taxes incurred will be paid by the Buyer. At the discretion of LR Environmental, if a service visit is deemed necessary after troubleshooting by phone or email, travel expenses will be paid by LR Environmental.
- 4. This warranty does NOT cover any costs incurred by the Buyer as a result of the purchase of LR Environmental equipment or any charges for the Buyer's labor for replacement, adjustment or repair unless authorized in advance by LR Environmental in writing.
- 5. LR Environmental is not liable for any direct, indirect, consequential or incidental damages including any damages for loss of business profits and business interruption due to the use of or inability to use the products. In no event shall LR Environmental be liable for an amount greater than the amount of the paid purchase order for the products.
